Management Report

- **1. Ratify Action without a meeting:** A motion was duly made, seconded and unanimously carried to approve the following email votes:

- **2. Declaration Amendment:** Based on homeowner feedback the Board has decided to revise the wording and complete a new amendment mailing.
- **3.** Homeowner Request for Variance: A motion was duly made, seconded and unanimously carried to grant a variance for 9275 W Freiburg Pl. regarding the snow plow that is occasionally attached to the front of their vehicle.
- **4. Audit / Taxes:** A motion was duly made, seconded and unanimously carried to approve McNurlin and Associates to only complete a tax return for 2011.
- 5. ACC Fence Form: The fence form that had been used in the past will be revised. The Board approved that anyone wishing to access their backyard via Association property must submit a \$1000 deposit check as previously required to the management company until the project and inspections are completed. If the owner is accessing via another organizations property then they must first receive written approval from that organization and submit with the DRC application for final approval. If a section of the Association fence must be removed then the homeowner will have two options: the Association will have its approved vendor remove and replace the fence at his hourly rate or the homeowner may opt to use their vendor and only pay for the Association to complete a final inspection following the fence replacement at the cost of \$35 flat rate.
- **6. Solicitation Waiver:** The Association has posted No Solicitation signs at the entrance to the community. Those wishing to solicit within the community may submit the solicitations waiver request for Board review. The Board will review and grant approvals based on individual circumstances.
